- O Group must complete and return the signed Winter Camp Agreement and deposit to secure their spots. The remaining balance due is to be paid prior to arrival for each camp.
- O Group is required to bring with them a copy of each camper's current medical form.
- O Group leader is required to have all parents and staff register and complete forms online through the LGYC registration system. Group leader should ensure that parents and staff complete and sign the Lake Geneva Youth Camp Recreation Release Waiver and COVID-19 Release Waiver online. Medical forms may also be completed through the online system. Groups who are unable to use the LGYC online registration system should contact the Camp Registrar at registrar@lgyc.org to make alternate arrangements.
- O Adequate supervision of campers is required. We recommend an 8:1 ratio of campers to leaders.
- O All staff must have background checks prior to attending camp and must have adequate child protection training. Training must include: MinistrySafe online training, eyeshot theory, 360-degree supervision, and general child abuse and neglect detection and prevention training. If you have any questions, please contact Jeff Andridge at jeff.andridge@lgyc.org.
- O The following are not permitted on LGYC property at any time: alcohol, tobacco products, illegal drugs, firearms, weapons, or fireworks.
- O Curfew is strictly enforced at LGYC and violation is grounds for dismissal from camp.
- O Your group is responsible for any willful, or otherwise, damage to any LGYC equipment or facilities.
- O Be involved. Make sure your group is on time to all events meals, programmed events, etc.
- OLGYC will have authority to make decisions regarding schedule changes, etc.
- OLGYC will provide all staff, food, equipment, program activities, speaker and worship experience for the operation of the camp program.
